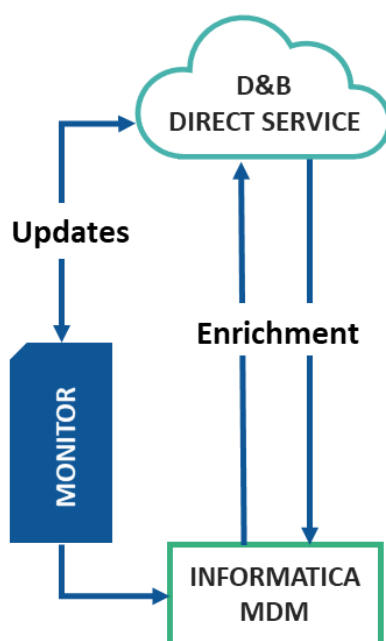
Globalsoft's *D&B Direct Monitor* is a stand-alone software component that manages the process of keeping your enriched data up-to-date.

The *D&B Direct Monitor* is designed to help subscribers of D&B Direct to:

- **Manage registration of DUNS to be monitored:** Add or Cancel DUNS for inclusion in the monitoring service
- **Retrieval and processing of change notices:** download and aggregate changes and output to a landing table
- **Configuration and Administration of the Monitor:** define the functionality and behavior of the Monitor.

Key Features

- **Clean & Simple UI** – The *D&B Direct Monitor* features a simple, user friendly, robust user interface which is easy to understand and operate.
- **Supports D&B's Popular Products** – It monitors data for the most popular products available for Enrichment from Dun & Bradstreet for company profile and corporate linkage.
- **Manual & Automatic Registration** – It provides an option to register the newly added records (DUNS) using a scheduled process. This feature is optional, and once enabled, allows the user to schedule the registration process to automatically run at a specific time (Intraday, daily, or weekly) based on preference.
- **Stand-alone Web Application** – The Monitor operate independently via a web browser.
- **Quick & Easy Installation** – A two-step process that requires installation of the database and the server. The *D&B Direct Monitor* comes bundled with the Tomcat server to set up the run-time component that manages all the monitoring services.



How it Works

The *D&B Direct Monitor* is a standalone application which retrieves the latest changes made to enriched records for all registered DUNS from D&B and processes these changes into a landing table. It is then consumed by a user-specific process to update existing D&B data to keep it current and complete.

The user interface showcases a minimal and efficient user interface to configure References and check the status of monitor jobs to retrieve and process notification. The following table describes the functions of the primary tabs available in the UI:

Dashboard	Displays charts and tabular reports with detailed metrics about DUNS registration.
Job Status	Displays all jobs that have ever been created, with their corresponding status. Provides the user with visibility into the job type, current status and when these jobs are expected to be completed.
Registration	The Registration tab displays a tabular report of all the registered DUNS data for each Reference, including details such as name of the Organization, Address and Country code. The Registration page allows a user to View, Add or Cancel Registered DUNS.
Configuration	Access for all configurable settings for the Monitor. It also provides access to the page required to create a reference for the D&B product monitored. (Only available to the user with <i>Admin</i> privileges)
Administration	All administrative activities for the Monitor are performed in Administration section. (Only available to the user with <i>Admin</i> privileges)
